3. **Confirmation and adoption of Minutes of the AGM held on Wednesday 11 November 2020**

5. **Co-Presidents' Report**
David thanked the following members of the UPJ Executive Committee:
Franklin Tate and Marsha Rosenberg (who stepped down) for their work and devotion;
Professor Larry Lockshin and Judi Hall for their leadership on the Relational Judaism initiative;
Sally Castle, for sharing her wisdom and expertise;
Helen Shardey OAM for rejuvenating ARZA to ensure Progressive Judaism and Zionism are pursued throughout the region;
Dorothy Graff OAM for sharing her wisdom on human resources and many other matters;
Danny Hochberg for his work on developing two educational initiatives,
Sue Silberberg for sharing her knowledge of Australian Jewish history and many useful ideas;
Associate Professor Josh Keller for sharing his education expertise;
Susan Kadar, Biennial committee chair, for her devotion, excellent listening skills and ideas;
Immediate Past President Roger Mendelson for driving the Placements Committee;
Sefi Shalom, Michael Sacks and Lior Kalisse, who show the importance of young leadership – they are not future leaders, but rather the younger current leadership;
Rabbi Nicole Roberts and Rabbi Shoshana Kaminsky for their valued rabbinic leadership;
Jocelyn Robuck, who keeps the UPJ running and is always calm above water but always paddling furiously below the surface; and
Brian Samuel OAM, as co-president – we complement each other and work for the benefit of Progressive Judaism.
David highlighted the importance of creating a higher profile for Progressive Judaism in Australia and NZ (not so much in Asia, for political reasons) and addressing Antisemitism, and said: “fighting antisemitism and standing up for Israel are two sides of the same coin”. He quoted Helen Shardey OAM, who said: “Diaspora Jewry must speak up when they disagree with policies, there is a point where such criticism is blatantly anti-Semitic.” He added: “We are refraining from commenting on the bill until the explanatory memorandum, yet to be released, is released. We understand (off the record) that most of the requests made by the Jewish community are being accommodated, including the explicit recognition of the Progressive stream of Judaism.”
Brian Samuel OAM said we are blessed to have a barrister as its Co-President, which has allowed the UPJ

to participate in presenting tremendous policy developments; and thanked everyone for their support over the past few years.
